

**NOTIFICATION FOR THE PURPOSE OF INSTALLING / USING SATELLITE EARTH TERMINALS OPERATING IN ACCORDANCE WITH THE 21<sup>ST</sup> AND 23<sup>RD</sup> SCHEDULES OF THE GENERAL AUTHORISATIONS (RADIOCOMMUNICATIONS APPARATUS) REGULATIONS (SL 399.40 of the Laws of Malta)**

**MCA/F/12-1210r1**

**Introduction**

1. With regard to radiocommunications apparatus, the Electronic Communications (Regulation) Act (Chapter 399 of the Laws of Malta)<sup>1</sup> provides that an individual licence is only required for the installation or use of apparatus, unless the apparatus is licence exempt or is regulated by a general authorisation.
2. The radiocommunications apparatus comprised in certain satellite earth terminals is regulated by the General Authorisation (Radiocommunications Apparatus) Regulations (S.L.399.40)<sup>2</sup>.
3. A person enjoying a general authorisation for the apparatus regulated by the 21<sup>st</sup> and 23<sup>rd</sup> Schedules of the aforesaid Regulations is required to obtain the necessary clearance from the Malta Communications Authority (MCA) prior to installing and, or using such apparatus.
4. The purpose of this notification is to ensure that satellite terminals regulated by the above-mentioned 21<sup>st</sup> and 23<sup>rd</sup> Schedules are not used within 500 meters from the boundary fence of an airport.
5. Officers from the MCA can carry out inspections on radiocommunications apparatus to verify the details provided in this form and to ensure compliance with the aforementioned laws.
6. Duly completed forms must be sent to the MCA at the address indicated in this form. Incomplete applications will be returned to the applicant.
7. The MCA shall act in accordance with the Data Protection Act (Chapter 440 of the Laws of Malta)<sup>3</sup> when making use of any personal information that may be provided.

**WARNING to all applicants** – Any false statement, wilful misinterpretation or concealment of any material fact on this form or on any document presented in support of this application may be grounds for criminal prosecution or other appropriate regulatory measures.
