## Modalities of Payment for General Authorisations and Rights of Use under the Electronic Communications (Regulation) Act, (Amendment) Directive, 2017

IN exercise of its powers conferred by Article 4 of the Malta Communications Authority Act, the Malta Communications Authority has made the following Directive:

Title	1. The title of this Directive is the Modalities of Payment for General Authorisations and Rights of Use under the Electronic Communications (Regulation) Act, (Amendment) Directive 2017, and it shall be read and construed as one with the Modalities of Payment for General Authorisations and Rights of Use under the Electronic Communications (Regulation) Act, Directive Number 1 of 2004.			
Purpose	2. The purpose for this Directive is to amend the Modalities of Payment for General Authorisations and Rights of Use under the Electronic Communications (Regulation) Act, Directive Number One of 2004, (hereinafter referred to as the "principal Directive"), to enable the Malta Communications Authority (hereinafter referred to as the "Authority") to take appropriate measures if an undertaking fails to submit its projected gross revenues for a given year and, or fails to make any payments as may be required in accordance with the Directive.
