Ofcom

Implementing Ofcom's decisions on the 57 – 71 GHz band

Ofcom is consulting on a proposal to make new regulations by statutory instrument. The new regulations change and extend the existing technical conditions and exemption from the requirement to obtain a Wireless Telegraphy Act licence for short-range devices and fixed wireless systems [read more].

Denmark launches multiband spectrum auction in the 700 MHz, 900 MHz and 2.3 GHz bands

The Danish Energy Agency (ENS), the national regulatory body responsible for spectrum management, published the final auction rules for the forthcoming award of frequencies in the 700 MHz, 900 MHz and 2.3 GHz bands [read more – subscription required].

Study on Fixed and Mobile Convergence in Europe 2017

This study examines FMC from the perspective of increasing European broadband connectivity through dense small cell networks. The analysis focuses on the practical side of 5G networking in terms of assuring quality of service and encouraging EU-wide coverage through regulatory obligations for mobile broadband. The study examines the quality of service indicators along with the whole framework necessary to introduce such a major transformation [read more].

Sweden relaunches 700 MHz spectrum auction

On 4 July 2018 the Swedish regulator PTS published the final auction rules for the forthcoming award of frequencies in the 700 MHz band. The award covers 2x20 MHz paired and 20 MHz unpaired SDL frequencies. The remaining 2x10 MHz block is reserved for DTT until end 2018 and its future use will be decided separately [read more – subscription required].
