

MONTHLY NEWSLETTER April 2025

INTERNATIONAL RELATIONS

Session organised by DOT Europe

The MCA participated in a session organised by DOT Europe, a body representing leading internet companies in Europe on 30th April, 2025. The event began with a keynote by the European Commission. The agenda covered the effective implementation of minor protection online, breakout sessions on the simplification agenda for the DSA and dispute settlement bodies, and concluded with a plenary on communicating the DSA effectively.

13th Meeting of the European Board for Digital Services

On 29th April 2025, the MCA participated in the 13th meeting of the European Board for Digital Services, which was held in Brussels. The event included a series of discussions and updates on key topics such as enforcement activities, systemic risks, data access, and the protection of minors.

10th Meeting of Working Group 3 of the European Board for Digital Services

The MCA participated in the 10th meeting of Working Group 3 (Content Moderation and Data Access) of the European Board for Digital services, which was held online on the 14th April 2025. The meeting focused on the main changes being adopted in the delegated act on access to data and the revised MoU.

7th Meeting of Working Group 2 of the European Board of Digital Services

Members from the MCA, participated remotely in the 7th meeting of Working Group 2 of the European Board of Digital Services on 10th April 2025. During the meeting, participants exchanged views on communication coordination and the establishment of a network of communication experts. Updates were provided on the progress of the Board report pursuant to Article 35(2) of the DSA and the drafting process of complaints. The group was reminded of the upcoming deadline for feedback on the revised incident response framework. Other topics discussed included future board meetings and cooperation with DSA officers.

Meeting with the German Digital Services Coordinator

On 4th April 2025, the MCA met online with the German DSC to explore details for an intern joining the MCA in Q4 for two weeks. The parties also discussed further opportunities for knowledge exchange, including on elections and policy

advisory structures.

The 63rd Meeting of Project Team FM22

Project Team FM22 focuses on spectrum monitoring and enforcement-related activities. The most recent meeting was held in a hybrid format from the 1st to the 4th April 2025. Key topics discussed included interference trends and statistics, space-based monitoring, and GNSS spoofing. The group also finalised the revision of ECC Recommendation (02)04 on EMF measurements to incorporate the introduction of 4G and 5G systems. The next meeting is scheduled to take place in September 2025.

Training Session organized by BEREC and Cullen International

An MCA official attended a virtual training session organized by BEREC and Cullen International on the 3rd April 2025. This session focused on the EU's Fixed Broadband goals and the State Aid rules currently in place, including compatibility criteria from both demand and supply-side perspectives, as well as subsidies granted by non-EU countries and their reflection on the EU's internal market.

Drafters' Meeting organized by the BEREC MEA WG

On April 2nd 2025, an MCA official attended a drafters' meeting in Brussels, Belgium, organized by the BEREC MEA WG, for the *BEREC Workshops* on the competitive effects of strategic fibre

deployment, including copper switch-off. During the meeting, drafters presented the progress made in their respective areas, with co-chairs and other WG members providing valuable feedback. A key challenge discussed was the difficulty of obtaining data for certain exotic countries. Following these discussions, the group agreed on which countries and indicators to include in the report and outlined the next steps for the work ahead.

13th BEREC Stakeholder Forum

The MCA CEO accompanied by the Chief Officer (External Relations) participated in BEREC's flagship stakeholder event held on 1st April 2025 at The Egg in Brussels. The Conference discussed the Outline BEREC Work Programme 2026 along with two panel discussions focusing on the '*Role of end users in the fast changing digital markets*' and on the '*Future of market power regulation*'.
